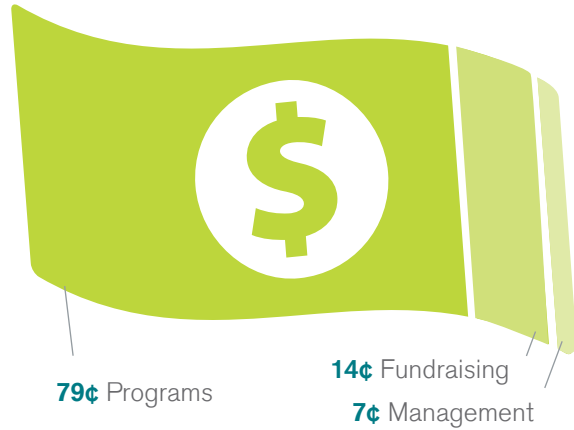
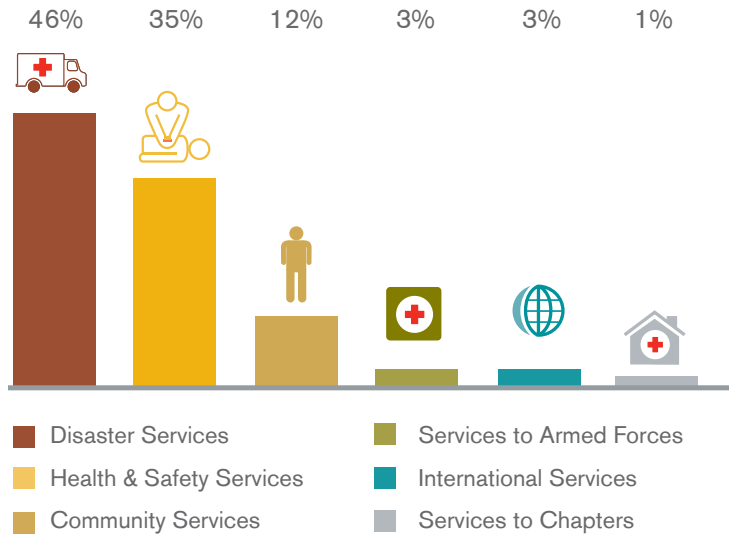

On average, each family we helped after a disaster received \$510 of direct financial assistance.



Last year, we taught more than 80,000 people First Aid, CPR and how to use an AED.



During area flooding in September 2008, we helped maintain 9 shelters and gave assistance for shelter, food or other supplies to more than 1,500 disaster victims.
